

SHORT TERM RECREATIONAL VEHICLE (RV) PARKING



Stanford Medicine Transportation Services provides RV parking permits to ensure that patients traveling a long distance for their appointment have a close and affordable parking option

Patient RV parking is available in Lot 1, located at 217 Quarry Rd, Palo Alto, California

RVs should park in the **H Permit** section of the lot, shown on the map below, and must purchase an RV parking permit.

HOW TO PURCHASE A PERMIT:

1. Apply online two business days prior to your arrival by downloading the Stanford Medicine Parking App or visiting the web version linked here: <https://shc.somnium-group.com/>

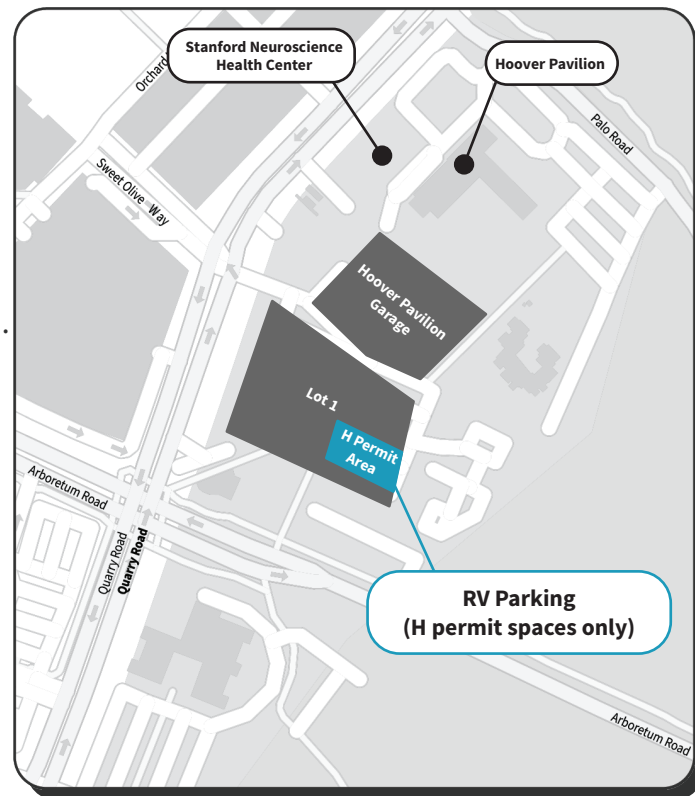


Please make sure to register as a “visitor” under “account type”.

2. RV applications will go through a patient verification process prior to approval.
3. Once your account is approved and verified, you may request to purchase an RV permit on the Stanford Medicine Parking app (see page 2 for RV permit request instructions on desktop).

*\$18 per day; 7 day (\$84) maximum
\$3 processing fee will be added to your total*

4. Once the RV permit is approved, an email confirmation will be sent that includes a copy of your parking permit and further instructions prior to your arrival.



RV parking is restricted to patients only.

All RVs and travel trailers must be less than 30 ft in total length and be fully self-contained.

(No electrical hookups, no water hookups, no sewer hookups, no dumping, no standalone generators, no open flames).

Parking is allowed for a maximum of 7 consecutive days, with no renewals.

HOW TO REQUEST AN RV PERMIT ON THE DESKTOP

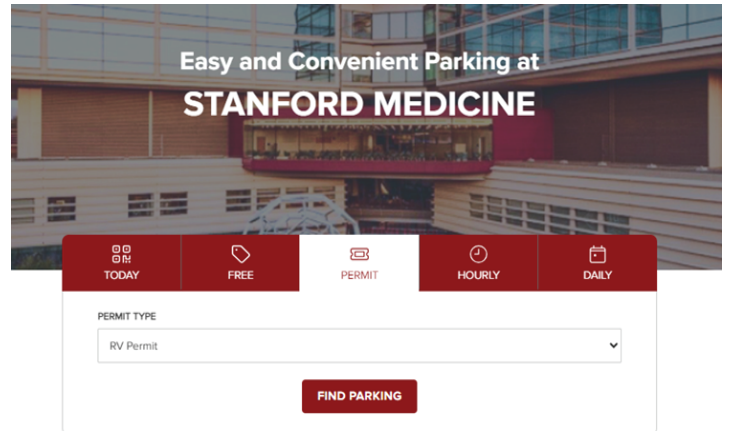
1. Go to <https://shc.somnium-group.com/>
2. On the homepage, select “Permit”
3. In the drop-down menu under “Permit Type”, select “RV Permit” and then select “Find Parking”
4. Fill out the RV permit request form

The form will include fields for entering the desired reservation dates, the license plate number, and payment details.

5. Once payment is received, an email confirmation will be sent that includes a copy of your parking permit and further instructions prior to your arrival.

6. To view all active and past parking permits:

- a. Click on your name on the top-right corner
- b. In the drop-down menu, select “My Account”
- c. On the lefthand navigation, select “Reservations”
